Rules of recruitment of foreigners for studies at the Grażyna and Kiejstut Bacewicz Academy of Music in Łódź

An excerpt from the document: "Rules of recruitment for studies at the Grażyna and Kiejstut Bacewicz Academy of Music in Łódź".

8. Rules of recruitment of foreigners

§50

- 1. Studies at the Academy in full-time and part-time form may be undertaken by persons who are not citizens of Poland.
- 2. Studies for foreigners are paid and together with the registration fee are equal to the proper amount in € converted to PLN, æcording to the Decision of Rector of the Grażyna and Kiejstut Bacewicz Academy of Music in Łódź, referring to payment for studies for foreigners.
- 3. Foreigners, defined in the art.43 paragraph 2, paragraph 5, paragraph 5a of the Act on Higher Education Law from 27th July 2005, may apply for studies according to the rules binding citizens of Poland.

§51

- 1. Conditions for accepting for studies include:
- a) holding a visa or residence card or other document entitling to stay within the territory of the Republic of Poland,
- b) holding an insurance policy in case of illness or accident for the period of education in Poland; or European Card of Health Insurance (EKUZ); or entering into an insurance contract in the National Health Fund promptly after beginning of studies.
- 2. Persons who are not citizens of Poland may be accepted for studies conducted in Polish after fulfilling conditions described in item.1 and also after:
 - completion of a year-long course preparing to undertake studies in Polish language, in centers determined by a proper minister of higher education, or,
 - holding a certificate of knowledge of Polish language issued by the National Education State Commission for the Certification of Polish as a Foreign Language, or,
 - receiving confirmation from the Academy that their preparation and level of knowledge of Polish language allows for undertaking studies in Polish language.
- 3. Persons who are not Polish citizens may be accepted for studies in a foreign language if they hold a document confirming knowledge of a

foreign language, in which the studies are conducted. Knowledge of a foreign language may be also confirmed by: certificates, diplomas or other documents confirming completion of a middle or high school, in which the classes were conducted in the same language as the language in which studies will be conducted in Poland. Foreign languages in which studies may be conducted are described in separate regulations.

§52

- 1. A candidate citizen of European Union country or citizen of a Non-European Union country may apply for studies according to the regulation of the Minister of Science and Higher Education from 12th October 2006 referring to undertaking and completing studies by foreigners and trainings and participation in scholarly research and development works (Law Gazette from 2006, no 190, item 1406).
- 2. All candidates holding International Baccalaureate confirmed by the Ministry of Science and Higher Education or certificate issued by IB Office in Geneva will undergo the recruitment procedure.
- 3. Candidates will register through submission of all required documents in the Teaching Section according to §77 item 6.

§53

- 1. Evaluation of candidate's predispositions is made by Examination Commission. Evaluation of candidate's predispositions may be performed by assigned representatives of Examination Commission, who perform qualification in the country of residence of a candidate. After evaluation of candidates a protocol shall be drawn up.
- 2. If a candidate for performance faculties has no possibility to appear before the Examination Commission, the Commission may decide to evaluate candidate's predispositions on the basis of submitted by the candidate phonographic material, composed of stylistically various works.
- 3. Evaluation of candidates' predispositions for 1st Faculty requires candidate's presence on the exams.
- 4. Candidates are required to present such level of knowledge of Polish language which allows for conducting an exam. The Academy is not obliged to conduct an exam in a foreign language.
- 5. Knowledge of Polish language is a condition of acceptance of a candidate for studies. The Academy is entitled to verify candidate's knowledge of Polish language.

- 1. Persons who are not Polish citizens entitled to study according to the rules binding citizens of Poland and being holders of scholarships of Polish party who undertake studies, are exempted from obligation to pay for studies.
- 2. Acceptance of persons who are not citizens of Poland for paid studies is made out of the student number recruitment limit defined by the Senate.
- 3. Acceptance of persons who are not citizens of Poland holders of scholarships of Polish party, is made within the general student number recruitment limit defined by the Senate.
